Governance:

RSMO 50.622.1 – County may amend the annual budget during any fiscal year in which the county receives additional funds, and such amount or source, including, but not limited to, federal or state grants or private donations, could not be estimated when the budget was adopted.

Revenue sources:

Transfer from Highway Department Unrestricted Fund which currently has a total balance of \$3,639,515.

Transfers between line items in Highway Budget.

#### **Recommendation:**

A net appropriation in the amount \$2,987,109 be made from the revenue sources mentioned in the previous paragraph in order to cover expenditures in line items of the County Highway Department Budget for the remainder of the fiscal year. Please review enclosure for details.

#### Additional Request:

The County Clerk has requested that a transfer of \$20,000 be made from the 'Voting Machine Maintenance' line item to the 'Voter Canvass' line item in the County General Revenue Election Budget in order to cover certain election related expenses for the remainder of the calendar year. Because this is a simple transfer from one line item to another, no additional appropriation is required and therefore will not affect the total General Revenue budgeted expenditures. I hereby recommend that the request by the County Clerk be granted and this change be made to the General Revenue Budget.
